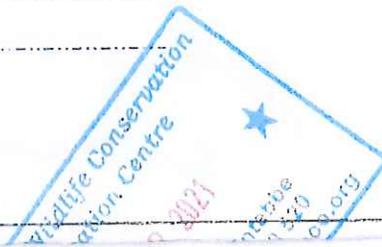

AND

**IN THE MATTER OF A MEMORANDUM OF AGREEMENT TO SPONSOR A LION
CUB AT UGANDA WILDLIFE CONSERVATION EDUCATION CENTRE(UWEC),
ENTEBBE, UGANDA.**

MEMORANDUM OF AGREEMENT

This Memorandum of Agreement is made this.....^{27th}.....day of.....^{APRIL}.....2021

BETWEEN

THE RUPARELIA FOUNDATION having its registered office at Plot 38 Kampala Road, P.O BOX 3673 Kampala Road, Kampala (hereinafter referred to as “**Ruparelia Foundation**”) which expressions shall where the context so admit include their successors and assignees in business) of one part;

AND

THE UGANDA WILDLIFE CONSERVATION EDUCATION CENTRE having its registered office at Plot 56/57 Lugard Avenue, P.O. Box 369 Entebbe (hereinafter referred to as **UWEC**) which expression shall where the context admits include its successors and assignees in Business) on the other part.

WHEREAS Ruparelia Foundation is a fully registered company with legal status under the Companies Act 2012, has the intent to support UWEC in promoting conservation education in Uganda.

WHEREAS UWEC is a Corporate Body that was established under the Uganda Wildlife Conservation Education Centre Act 2015 mandated to promote, conserve and develop wildlife resources.

WHEREAS the sole purpose of this Memorandum of Agreement is to encourage sponsorship and partnership between Ruparelia Foundation and UWEC.

NOW THE MEMORANDUM HEREBY WITNESS AS FOLLOWS: -

1. That the parties have agreed to enter a Memorandum of Agreement whereby Ruparelia Foundation intends to extend financial support to UWEC towards the daily operation and sustainability of one cub at UWEC premises through a partnership.
2. That UWEC shall remain the governing authority of the cub and holds a superior position in all decisions of the cub without interference from the Ruparelia Foundation.
3. That **UWEC shall perform the following obligations;**
 - a) Provide entrance and access to baby lion for the **Ruparelia Foundation** Management 2 (two) times a year, with Behind-the-Scenes experience.
 - b) Provide sponsorship Identification Card to **Ruparelia Foundation**.
 - c) Recognise **Ruparelia Foundation** in UWEC annual newsletter called the zoom.
 - d) Guide **Ruparelia Foundation** Management on safety issues during their visit to the centre.
 - e) Provide a personalized sponsorship certificate to **Ruparelia Foundation**.
 - f) Provide an attractive 8x10" photo and information about the baby Lion cub.
 - g) Recognise **Ruparelia Foundation** on Social media per visit.
 - h) Allow branding of **Ruparelia Foundation** at UWEC sponsorship board.
 - i) Provide 5 VIP car parking stickers to access UWEC.
 - j) Free Camping space once a year for Ruparelia Foundation Management.
 - k) Allow Ruparelia Foundation to name the lion cub a name of their choice
 - l) Branding at the Lion exhibit



4. That **Ruparelia Foundation** shall perform the following obligations;
 - a) Shall pay a Contract naming price of Ugx15,000,000 (**Fifteen Million Uganda Shillings only**) payable on signing the contract.
 - b) Support the welfare of baby lion (Cub) like feeding **at will**.
 - c) Name the lion cub **ARIE**. The lion cub will be called Arie for as long as he lives.
5. That this Memorandum of Agreement with benefits shall run until April in the year 2026
6. That UWEC is not stopped by Ruparelia Foundation from entering into other beneficial contracts with any other 3rd Party, if such contracts are for the development of the said cub at UWEC but not giving a name.
7. That if parties to this Memorandum of Agreement make any changes in effect to this document before the expiry, it shall be in writing and shall be subject to approval by either the signatories or their Successors. However, such changes shall not affect whatever development already established nor defeat its purpose.
8. That the Memorandum of Agreement shall take effect on the day of signing and maybe terminated by either Party by not less than 30 days written notice to the other party and termination shall only be initiated by the Signatories to this document.
9. That UWEC will not be responsible for losses or accidents that may arise out of **Ruparelia Foundation** negligence or failure to observe protocols and procedures communicated verbally or otherwise implied by the Management of UWEC during the visit to the sponsored baby lion (Cub).
10. That this Memorandum of Agreement shall be governed by the laws of Uganda and each party submits to the exclusive jurisdiction of the Courts of Uganda in the relation to the matter arising from the Memorandum.
11. That parties promise to live to the doctrine of utmost good faith with the guilty party indemnifying the innocent in any event.
