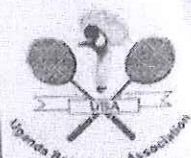

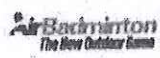
Uganda will be represented by a team of Sixty Seven players (67) plus four coaches.



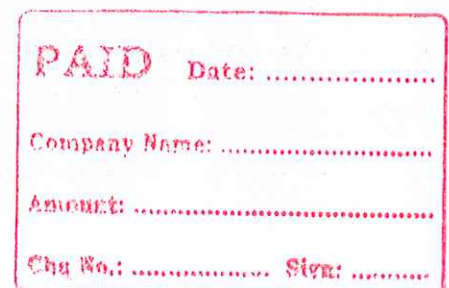

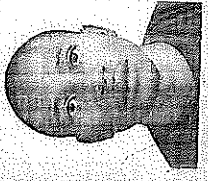
