Sir, I very much need to continue with my studies if possible. Preferably take Human Resource Management.


Therefore, the purpose of this letter is to request you for a Scholarship at Victoria University through Ruparella Foundation.

Sir, alternatively, I would refund the Tuition fees incurred on me after graduation once given an opportunity to work in any of your Companies. Attached are my Certificates.


