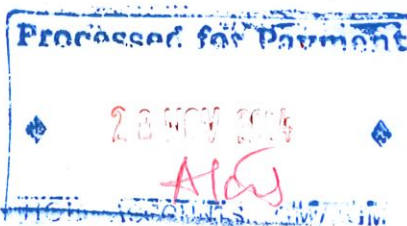

We remain confident in your support and commitment to uplifting communities, and we look forward to your kind response.

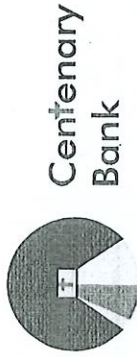
